## Royal New Zealand Pipeband Taranaki Centre

At 9.22am, John Campbell, of the Royal New Zealand Pipeband Taranaki Centre, joined the meeting.

Mr Campbell advised that the Taranaki Centre was hosting the New Zealand Pipeband championships on 19-22 March 2026. The event will be based in Inglewood, at the TET Stadium and Events Centre, and will also include a Street March. This is the first time since 1948 that the event will be hosted in Taranaki. There are 57 bands that will attend, with 1,200 playing members expected. Various costs will be incurred for the event. Mr Campbell will firm up on these before submitting an application.

## **AmeriCARna**

Glen Adams and Matthew Dimock (Stratford Business Assn – arrived at 9.52am), Marie Pearce (Inglewood First Trust – arrived at 9.55am) and Sarah Bentley-Korff (Waitara Alive – arrived at 10am) joined the meeting.

The event continues to work well in Stratford. It brings farmers and school children together and is a good community event. Mrs Pearce spoke to her written report, highlighting that 8,000-10,000 attend the Inglewood event annually, which is the most popular event on the Inglewood calendar. Waitara have seen no growth with their event over the past four years, but it remains a popular community event.

All three organisations noted that the events would not be possible without the support of TET. No funding has been received in the past from AmeriCARna or the Taranaki Vehicle Events Trust, but this year Inglewood received some support for the Band. It was noted that the events would not occur without

the wider Festival. Mrs Pearce is due to meet with AmeriCARna organisers shortly and will circulate a summary of this meeting.

Glen Adams, Matthew Dimock, Marie Pearce and Sarah Bentley-Korff all left the meeting at 10.34am.

The Trustees agreed that the events are important in all of the towns, and that the organisations be thanked for their work and invite them to submit applications for next year.

# Stratford Park Equestrian Complex Charitable Trust

The Trustees discussed correspondence from the Stratford Park Equestrian Complex Charitable Trust (SPECCT) requesting additional funding for stages one and two of the project.

Mr McDonald moved that an additional \$839,100.00 be awarded, subject to the provision of a suitable Trust Deed, to enable stages one and two of the project to be completed. The motion lapsed through the lack of a seconder.

It was agreed that SPECCT be asked to submit a full application, provide details of their charitable status and Trust Deed, and correspondence from the Stratford A&P Assn agreeing to the transfer of the \$200,000.00 awarded in October 2024 to SPECCT.

## **Craigs Investment**

It was noted that with the existing troubles in the world, the Investment Portfolio had declined in value by just over \$2,000,000.00 since 31 December 2024.

## **General Business**

There was no general business for discussion.
