TET Grants Budget for the year - Budget vs Actual

The report 'Grants Approved Y/E 30/06/24 (as at 31/03/24)' had previously been circulated Mr Hassall spoke to the report, which was received.

Trust deed review

Mr Hines has progressed his research and is scheduled to attend the June meeting.

Annual plan

The current Annual Plan and Policy on Income Distribution document was discussed in preparation for the new financial year. It was agreed that the religious section is adequately covered as part of general grants and does not need its own section. As part of the public consultation of the Trust Deed review, the public should be advised that the policy moving forward is to remove energy-related charitable purposes, as these are still covered by normal charitable purposes. Consideration shall be given to special projects. The wording of options for funding of individuals can be simplified.

Fluxx grants system

Glen West and Alice O'Donnell of the TOI Foundation joined the meeting at 10.05am. They gave an illustration of the Fluxx system, the advantages, support on offer, prospects how local funders could work together with the system, and answered questions. Mr Hassall will liaise with Mr West as to how the use of the system could occur.

Glen West and Alice O'Donnell left the meeting at 10.50am.

Age Care Central Limited

Chairman Davey opened a discussion on ACCL and invited Mr McDonald to speak. Mr McDonald gave a background to the organisation, including its formation and key developments. Occupancy is lower than anticipated at the moment.

Chairman Davey thanked, on behalf of TET, Mr McDonald for his excellent and long service to ACCL and the need to find a long-term solution.

Because of his conflict of interest, Mr McDonald left the meeting at 11.24am.

Chairman Davey suggested that the debt of the facility could be retired in equal tranches over the current and following two financial years. Mr Erwood noted that the beds should be full within 3-6 months and that no formal application had yet been received from ACCL. The procedure of such an application was also highlighted by Mr Bedford and Mr Jamieson.

After discussion, it was resolved that:

- TET will pay, if required, for a valuation to be completed on the land and buildings in order to determine how ACCL could get into a bankable position;
- A formal application with a specific request be submitted, including an applicable resolution from the Directors;
- Until 30 June 2024 the loans shall be interest-free and principal-free.

Mrs Stevenson spoke to a contract to engage Belinda Burke to advise and make recommendations to IWSI. She will report to TET monthly, with a maximum of 20 hours per month. The contract is for a period of six months.
